Doug: we have been advised that at least 1 table will fit in the goods lift.

Doug: Collection & installation is at purchasers expense

Ted: Bylaws state that the results from weeks 1-7 stand, all other matches are forfeited until fees are paid.

Ted: No.

Keep sending results to Chris until the end of the season. New arrangements will be announced before the start of next season.

??: An extra team has joined The Maram - does the draw change?

Doug: The draw does not change. There are 7 teams, so a maximum of 14 tables are required. The association is not responsible for scheduling the tables. The Maram team captains must advise the venue that 14 tables are required. If sufficient tables are not available, the opposing team have the right to claim a forfeit.

Rolf Bandte advised that he is no longer associated with The Maram.

Wayne: when will ranking points be updated?

Doug: after the end of the season.

Rolf: Home teams must brush & block tables before the start of play

Doug: If tables have not been brushed and blocked, the away team caption should ask home team captain before play commences.

Matt advised that he was unable to play in the top-16 round of the selection trials as he was overseas with his wife (Kylie) while she competed in the World Championship. He has been allocated the ranking points of 15th place (both he and Nicole had to forfeit their Top-16 matches). He asked that he be allocated the same ranking points as last year.

Theresa S: Is there a precedent?

Kenny Nicol was allocated the previous years points when he represented Australia

Matt Harmon was allocated an average

JR: perhaps an average of the last 5 years points

Theresa S: what is the difference in points

Doug: 80 points

JR: Matt did not compete at the World Championships, so should not get the points

The shot is fair – the player must nominate, then play on.

When the player nominates the colour that was not potted, the table is open. The nominated colour must be played, but any ball can be potted.

This generated an active discussion and it was agreed to hold over a motion until next meeting.
