#### 9. Head Umpire's Report

- A number of questions were asked at the Feb meeting about recent rule changes that came into effect on 1 January 2015. Steve provided the following clarification:
  - You must strike the cue ball with the tip of the cue or it is a loss of frame foul e.g. where you tap the cue ball for a deliberate foul, you must touch the cue ball with the tip of the cue and not the ferule.
  - Where you have ball in hand (cue ball), you are able to move it around the baulk area with the shaft of your cue.
  - There is NO penalty for breaking when the balls are racked incorrectly e.g. where two yellow balls are at the front of the rack instead of two red balls. Players are encouraged to continue to rack using two reds at the front to achieve consistency with national standards.
